Council advised Mr Newland that he should provide Sevenoaks District Council with all information initially including that relating to the London Borough of Bromley.

#### 9.4 Update on allotments

There had been some problems with the water supply but this had been rectified. Tenancy agreements have been circulated and some have been returned with rental. Several allotmenteers have complained that their neighbouring plot has not been cleared and the weeds are spreading. The Amenities Committee will discuss this.

# 9.5 <u>Update on internal improvements to the Pavilion</u>

A draft layout plan was provided by John Brett. All the work is to be carried out by Mortimer Construction who are also providing the materials and is part of a sponsorship agreement. Work will start in the near future.

# 9.6 <u>Memorial bench on the Recreation Ground</u>

Request made by Mr Ralph Allen, a Knockholt resident, who would like to provide a bench. He understands that he must carry the cost of installing the bench and maintenance as well as purchase cost.

Cllr. Brooker proposed, seconded by Cllr. Baldwin that this should be permitted, carried unanimously.

## RESOLVED that Council will accept the offer from Mr Allen of a bench on the Recreation Ground.

Cllrs Brooker and Baldwin will provide Council with a suitable location for its siting at the next meeting
